Important information for NRI, Defence/Paramilitary and PwD candidates

The NRI, Defence/Paramilitary and PwD candidates (as per the list dated 17.11.2022 placed at the website) are required to physically present themselves for Document verification and allotment (on vacant seats) before the Board, **on 22.11.2022 at 9.00 am, at Govt. Dental College (RUHS College of Dental Sciences) Subhash Nagar, Behind T.B. Hospital, Jaipur** positively for considering their allotment against respective category:

Such candidates are eligible to participate in round 2 allotment process for Govt./General/Management seats at their common merit point and eligibility criteria.</p> <p>Candidates who participate in round 2 NRI allotment process and get / retain a NRI seat are automatically excluded from general merit and shall not be allowed to participate in round 2 allotment process for Govt./General/Management seats.</p> <p>Candidates who get allotment on NRI seat shall submit the requisite bond at the time of allotment.</p>	22.11.2022 (9.00 am)
